The club will hold an Open to Centre trial for solo machines only. To be held under the National Sporting Code rules of the ACU, the Standing Regulations for trials, these supplementary regulations and any final instructions which may be issued up until the start of the trial.

Entry fees: £12 adults / £10 youths. Cheques payable to Stratford-upon-Avon MC&LCC. Must include 2 x SAE or an email address. Entries will close on 5th December 2010. Entries will be accepted up until 9:00am on the day of the trial at a cost of £15.00 adults / £13 youths, but riders will not be eligible for awards or championship points.

Venue and Start Time: Hancock's. 1st rider on each route away at 10:01am, the rest at one minute intervals. The method of marking for this trial will be TSR22A. Petrol is not available at the start.

Course: The trial will be of a sporting nature and will have 3 routes.

Note: Events run as a grade A open to Centre Trials. Any affiliated member of a Midland Centre ACU club can enter the trial. Experts and Intermediates must ride the hard route, Clubmen and Over 40s must ride the medium route, to qualify for awards and points.
